

**Oyster Point Breakwater Modification Project-Completion Ceremony**  
**9:00am-12:00pm, Friday, February 22<sup>nd</sup>, 2013**

1. Project Description: In 2009 the USACE, in partnership with the San Mateo County Harbor District (SMCHD), completed a modification of the existing breakwater at Oyster Point which allowed for a more direct and wider approach for larger vessels, including the Water Emergency Transportation Authority's (WETA) commuter ferry. This project was followed by the construction of an in-basing floating breakwater system, completed in 2012, which decreases wave agitation in the inner harbor. After several years of planning, engineering, design, and construction, the Oyster Point Marina Breakwater Modification Project has accomplished its mission of widening the harbor entrance without significantly increasing wave agitation within the harbor.
