Last May I resigned as Chair of the CMIA, because I no longer represented Santa Cruz Harbor, and that is a requirement of the Authority. Peter Grenell is now acting Chair of the CMIA and the continuing Chair of the CMIB. He has authorized me to contact you and make the proposals herein.

Lisa Ekers is the Port Director for Santa Cruz and she or her designate now represent that harbor in all matters of the Bank and Authority. We welcome Lisa.

On August 31 I sent a memo around proposing a reorganization which would appoint me as the non paid Executive Officer of the the CMIA and the CMIB. This would allow Doug Charchenko to step out of the Executive Officer position and return to being the Financial Advisor only, which he prefers. I have attached the 31 August letter. Please re-read it, and be prepared to express your thoughts on this matter. My proposal is only one idea, and it's just for a year. If there is another plan please present it. I would be happy to have another member take the leadership for a longer term. It's just an option at this point in time.
